Steve Solsky Superintendent's Report



I just have a few things to update everyone. The first is the condition of the course.

As most of you know, we have four temporary greens (7,9,14,16). As I feared back in March when we cleared the snow and ice off the greens, we had significant damage. The prolonged ice cover killed the poa annua and stunted the bentgrass on our greens. The four greens that took the most damage had a decaying smell to them, indicating that the turf suffocated under the ice. My crew and I acted quickly to save what we could by aerifiying the greens. We then used a verticut mower to dethatch the dead turf and create channels to seed into. Finally, we topdressed the greens and fertilized.

The covers that you see on the greens are designed to keep the greens warm and to protect the new seedlings. In order for the greens to be playable again, the weather needs to cooperate. We need warm weather and we need a little rain to help the greens to recover. The saying "April showers bring May flowers" holds true to grass as well. Warmth and showers will help the seed to germinate and the greens will come back.

While waiting for the grass to germinate on the greens, my crew and I have been busy cleaning up the course and working on the new 14th tee. We leveled the subgrade and are in the process of installing the irrigation. The next step will be topsoiling the surrounds and putting root zone mix on the top of the two tees. Once this is completed, we will order the sod and lay it all around the tee area and seed the tops. I hope to have this done in the next few weeks.


Green Committee Report

By the time you read this hopefully most of you have had a chance to come out and play. I'm sure you noticed that Steve and his crew have done an outstanding job cleaning up the winter debris.

The Green Committee met on March 25th to establish priorities for the season as well as get an update on membership and budget. Unfortunately, with the current membership level and outside tournaments booked to date we will have to be very conservative in expenditures and limit projects to only those that are necessary. On a positive note I am pleased to report that \$2,800 was received from the sale of wood from the tree thinning efforts on hole #3

and between holes #14 and #15.



Finally, I want to thank the nearly 40 members who volunteered their time on Project Day. Projects that were completed include: the fence at the entrance got a fresh coat of paint, the deck overlooking # 9 was stained, the rotted handrail on the handicap ramp was replaced, the clubhouse was power washed, electric work was done to accommodate the new air conditioner in the clubhouse, painting continued in the women's locker room, a new rock wall was built at the back of the clubhouse overlooking the 18th green, flower beds were edged and mulched, a hand rail on the #17 steps was built, the walk bridge on #17 was painted and sumac trees were removed to the right of the men's tee on #13. It was great to see such a large group of people come together and work to improve our club.

First Hole

With the new rock wall on the green side of the 1st hole, we may have a few questions that may come up for discussion. First if your ball flies into the rocks and bounces off into another part of the golf course, then the USGA rules of golf state that the ball may or may not be in the hazard. In order for the ball to be deemed into the hazard then the player must have reasonable evidence that it remained in the hazard. If there is not reasonable evidence that the ball is in the hazard, then the ball is then deemed to be lost.

Eighteenth Hole

The 18th hole now has a rock wall behind the green and is close to the clubhouse. A white line will be close to that wall and the wall is considered out of bounds. If the ball lies close to the wall and the wall impedes your golf swing, the ball must be played from where it lies. There is no relief from the wall without a penalty.

Golf Lessons

I have recently been changing my golf swing to a recent swing that has been marketed as the Stack and Tilt. This will be the method that I will be teaching this season and the future. I attended a seminar by the two instructors of the method last fall at Turning Stone Casino. The 2 instructors are Andy Plummer and Mike Bennett. It is a simple way to play the game and has helped me become much more consistent and allows me to hit more solid, crisp shots each and every time with every club. I enjoy teaching this method very much and feel it will help you also if you put the time in and be patient in learning it. There are many tour players that use this swing and have had much success in the PGA Tour with this method and it is a swing that I feel is easy to repeat.

Anyone interested in learning this can schedule a lesson with me and get started on this soon to start making the change. Anyone interested in scheduling a lesson with Jeff Nackel can do so by logging on to www.golfnack.lattiss.com. This is a site that you can log on and schedule online.

Score Posting

We have a few temporary greens that we are playing on for now and I spoke with the USGA and the player will add 1 stroke to their score for posting purposes. The player will only add a stroke to their score if that hole is a handicap hole that they would normally receive a stroke on.
